

ALL that piece, parcel or lot of land with improvements thereon situate, lying and being on the Westerly side of Nora Drive in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 1 on plat of Bruce Heights, prepared by C. C. Bruce, Engr., and revised August 23, 1956 and recorded in Plat Book LL, at page 73, R.M.C. Office for Greenville County and having, according to a recent survey made by R. B. Bruce of the property of Leroy Davis dated March 26, 1959, the following metes and bounds, to wit:

BEGINNING at an iron pin on Nora Drive at the joint front corner of Lots Nos.1 and 2 and running thence with Nora Drive, the following courses and distances: South 10-36 West 50 feet; thence South 38-31 West 50 feet; thence South 66-26 West 50 feet; thence N. 82-24 West 53.9 feet to an iron pin; thence leaving Nora Drive and running thence North 16-20 West 140.3 feet to an iron pin at joint rear corner of Lots Nos. 1 and 2; running thence with the joint line of said lots, South 79-39 East 181.8 feet to the point of beginning.
