All that lot of land in the county of Greenville, state of South Carolina, being known and designated as Lot No. 5 of a re-subdivision of Lots Nos. 275, 276 and 277 of Augusta Acres subdivision as shown on plat of property of Clyde Dorr recorded in plat book SS page 107 of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made by J. W. Hill, March 6, 1959 the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the north side of Churchill Circle, the front joint corner of Lots Nos. 5 and 6; thence with the joint line of said lots N. 27-20 W. 364.6 feet to an iron pin; thence S. 50 W. 41 feet to an iron pin the rear corner of Lot No. 7; thence with the rear corner of said lot S. 67-30 W. 13 feet to an iron pin in line of Lot No. 8; thence with the line of said lot N. 8-10 W. 79 feet more or less to a point; thence continuing with the line of said lot N. 20-14 W. 382 feet more or less to an iron pin; thence N. 58-22 E. 153 feet more or less to an iron pin corner of Lot No. 4; thence with the line of said lot S. 20-57 E. 431 3 feet to an iron pin corner of Lot No. 4; thence with the line of said lot S. 20-57 E. 431.3 feet to an iron pin on the north side of Churchill Circle; thence with the north side of said Churchill Circle S. 61-12 W. 21.9 feet to a point; thence continuing S. 62-28 W. 63.5 feet to the beginning corner.
