All that certain piece, parcel, or lot of land with the buildings and improvements thereon, situate, lying and being on the Northeast side of State Highway No. 14 (formerly U. S. Highway No. 276), near the Town of Simpsonville in Austin Township, County of Greenville, State of South Carolina, and being shown and designated as Lot No. 3 on Plat of Property of Minnie C.
