of South Carolina, on Lake Drive, and being known and designated as Lot No. 79 of Pioneer Park Property as shown on a plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book G at page 80, and reference is hereby made to said plat, the said property having the following measurements, to-wit:

BEGINNING at an iron pin on the Western side of Lake Drive at the joint front corner of Lots No. 79 and 80 and running thence in a Northerly direction with said Drive 50 feet to an iron pin; thence continuing along the curve of said drive 62.3 feet to an iron pin; thence continuing in a Northwesterly direction with said drive, 60 feet to an iron pin at the joint corner of Lots 78 and 79; thence along the joint line of said lots in a Southerly direction 76.8 feet to joint rear corner of Lots No. 79 and 80; thence along the line of said lots in an Easterly direction 133.4 feet to the beginning corner.
