

Timmons and Eva Doris Timmons, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 46, as shown on a Plat of Fore Estates, subdivision, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 61, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Lockman Drive, joint front corners of Lots Nos. 45 and 46 and running thence along the line of said lots, N. 14-51 W. 160 feet to iron pin; thence running, S. 75-09 W. 100 feet to iron pin rear corner of Lot 47; thence running with line of said lot, S. 14-51 E. 160 feet to iron pin on Lockman Drive; thence running with said Drive, N. 75-09 E. 100 feet to iron pin at point of beginning.
