released, and by these presents does grant, bargain, sell and release unto GRACE INDEPENDENT
CONGREGATIONAL METHODIST CHURCH, its Successors and Assigns forever:
ALL that piece, parcel, or lot of land, situate, lying, and being in the City of Greenville, on Townes Street, County and State aforesaid, and having the following metes and bounds, to-wit:
BEGINNING at an iron pin on Townes Street at joint corner with lot with ten foot frontage conveyed to Green by Louis B. Thomas on June 9, 1925, and lot herein conveyed and running thence with said Street fifty feet to an iron pin; thence N 72-15 W 146 feet to an iron pin, joint corner of Lots Nos. 2 and 3; thence S 12 W 48 feet to an iron pin; thence S 71-15 E 149 feet to the beginning corner, being a portion of Lot No. 2, see Plat Book "E", Page 255 in the R.
