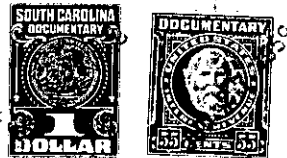

That I, Minnie Lee Harper in the State aforesaid, in consideration of the sum of Three Hundred (\$300.00) * * * * * DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. W. Acker and M. L. Waldrop,

All that piece, parcel or lot of land in Greenville County, South Carolina, on the South side of Wilbanks Street, being known and designated as Lot No. 9 on a map of West Boulevard, property of I. Saul, made by R. E. Dalton, Engineer, in August 1924, recorded in the R. M. C. Office for said County and State in Plat Book "F" at page 246, and, according to said plat, being described as follows:

BEGINNING at an iron pin on the South side of Wilbanks Street, at the joint corner of Lots Nos. 9 and 11, and running thence with Wilbanks Street, N. 79-45 E. 60 feet to the joint corner of Lots Nos. 7 and 9; thence with the line of lots nos. 7 and 9, S. 10-15 E. 150.9 feet to the rear corner of Lots Nos. 7 and 9; thence with the line of Lots Nos. 8 and 9, S. 78-50 W. 60 feet to joint corner of lots Nos. 9 and 11; thence with the joint line of Lots Nos. 9 and 11, N. 10-15 W. 151.6 feet to the beginning corner, and being shown on the County Block Book as 230-8-11. This being the same property conveyed to the grantor herein by A. E. McKinney by deed dated the 27th day of March, 1959 and recorded in the R. M. C. Office for Greenville County in Deed Volume 620 at page 501.
