Ducker, his heirs and assigns forever: All that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the southern side of Lee Road and the northeastern side of Brushy Creek Road, containing 1.24 acres, and having, according to a plat of the property of R. F. Watson, Jr., et al, prepared by C. O. Riddle, Surveyor, December 18, 1956, the following metes and bounds, to-wit: BEGINNING at an iron pin on the southern side of Lee Road near the intersection of said Lee Road with Brushy Creek Road and running thence along the southern side of Lee Road N. 82-40 E. 100 feet to an iron pin; thence continuing along the southern side of Lee Road N. 78-29 E. 100 feet to an iron pin; thence continuing along the southern side of Lee Riad N. 71-22 E. 119.4 feet to an old iron pin; thence leaving Lee Road and running S. 8-24 E. 345.7 feet to an old iron pin on the northeastern side of the Brushy Creek Road; thence along the northeastern side of the Brushy Creek Road N. 51-00 W. 100 feet to an iron pin; thence continuing along the northeatern side of the Brushy Creek Road N. 54-32 W. 100 feet to an iron pin; thence continuing along the northeastern side of the Brushy Creek Road N. 57-00 W. 245 feet to an iron pin near the intersection of the Brushy Creek Road and the Lee Road; thence around the curvature of said intersection 25 feet to the beginning corner.
