All that piece, parcel or lot of land situate, lying and being in Dunklin Township, County and State aforesaid, and having, according to a plat of said property, made by T. J. Leslie, Surveyor, June 18, 1959, the following courses and distances, to-wit:

BEGINNING at a point or pin in the intersection of a Secondary County Road No. S-158 with Highway No. 76, and running thence along said County Road, N. 69.45 W., 487 feet to pin in center of Secondary Road S-158; thence S. 65 W., 291 feet to point on bank of Saluda River; thence down the Saluda River as the line, approximately 450 feet to a point in center of said river and Highway No. 76; thence along Highway No. 76, N. 52.20 E., 544.5 feet to the beginning corner, and containing 4.15 acres, more or less, and being a part of the property heretofore conveyed to Hugh Drake by Earle Benson and Faul Benson, and later conveyed to the grantor herein by the said Hugh Drake.
