All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County pf Greenville, State of South Carolina, being known and designated as Lot 17, Map No. 2 of Cherokee Forest, plat of which is recorded in the RMC Office for Greenville County, S. C., in Plat Book EE, pages 190 and 191, and having the following metes and bounds, to-wit: .
