"ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, located on the North side of Fortner Street, near the City of Greenville, being known and designated as Lot No. 13 on plat of property of John E.Burden by R. E. Dalton, Eng., June 9,1910 and recorded in Flat Book "A" at page 409, RMC Office for Greenville County: BEGINNING at a stake on the North side of Fortner Street 60 feet West from Jones Street at corner of Lot No. 12; thence with the line of said lot, North 12-44 East 148.4 feet to a stake in line of Lot No. 8; thence with lots Nos. 8 and 9, North 81-39 West 60 feet to a stake at corner of Lot No. 14; thence with the line of said lot, South 12-44 East 147.8 feet to a stake on Fortner Street; thence with the North side of said street South 81 East 60 feet to the BEGINNING corner; being the same land conveyed to Darrell D.
