All of that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near Gantt Station, being shown as Tract No. 3 on plat of property entitled Property Plat of W. F. LaBoone Estate recorded in the R. M. C. Office for Greenville County in Plat Book SS at page 97 and having the following metes and bounds according to said plat:

BEGINNING at a point in the center of Murrell Drive joint front corner of Tracts Nos. 2 and 3, ( iron pin being located on joint line of Tracts Nos. 2 and 3 at distance of 27 feet from the beginning point); and running thence along the center of Murrell Drive N. 67-18 E. 258.7 feet to a point in the center of Murrell Drive; thence continuing along the center of Murrell Drive, N. 14-12 E. to point on line of Poplar Valley Property ( iron pin being located on line in easterly direction 12 feet from said point); thence S. 32-35 E. 99.7 feet to an iron pin; thence along the line of Earle property, S. 32-35 W. 296.5 feet to an iron pin; thence N. 58-58 W. 219.5 feet to the beginning corner. .
