

Thornton, Trustee, made by C. M. Furman, Jr., Engineer, dated April 25, 1925 and recorded in the R.M.C. Office for Greenville County in Plat Book G, Page 23, and having the following metes and bounds, to-wit:

BEGINNING at a point on the north side of East Earle Street, 105.16 feet from the northwest corner of East Earle Street and Chick Springs Road, joint corner of Lots Nos. 2 and 3, and running thence with the line of Lot No. 3, N. 19-35 E. 133.69 feet to a point, joint corner of Lots Nos. 2 and 3; thence N. 71-20 W. 53.6 feet to a point, joint corner of Lots Nos. 1 and 2; thence S. 133.87 feet to a point on the north side of East Earle Street, the joint corner of Lots Nos. 1 and 2; thence S. 71-35 E. 52.66 feet to the beginning corner and being the same property conveyed to me by Sadie Davis Wyatt by her deed dated September 24, 1947 and recorded in the R.M. C. Office for Greenville County in Deed Book 320, Page 357.

ALSO. All that certain piece, parcel and lot of land situate, lying and being in the City of Greenville, County and State aforesaid, known and designated as Lot No. 3 on a plat of property of A. H. Pyron, et al., J.G. Thornton, Trustee, made by C. M. Furman, Jr., Civil Engineer, dated April 25, 1925, and recorded in the R.M.C. Office for Greenville County in Plat Book "G" at Page 23, and having the following metes and bounds, to-wit:

BEGINNING at a point on north side of East Earle Street, within the corporate limits of the City of Greenville, County and State aforesaid, and running thence along said street, S. 71-35 E. 52.66
