FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is WEBSTER OIL COMPANY

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to purchase, store. transport, distribute and sell petroleum, petroleum products, and allied lines; to purchase, sell, repair, and deal in tires, batteries, and automotive accessories and supplies of all kinds; to buy, own, exchange, operate, mortgage, lease and manage real and personal property of all kinds, both as principal and agent and at either wholesale or retail; to do all things incident or necessary to such businesses, and in general carry on any business not contrary to the laws of the State of South Carolina; and to have and to exercise all the powers, rights, and privileges conferred by the laws of the State of South Carolina upon corporations organized thereunder.
