All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the southeastern corner of Airport Road and Liason Avenue near the City of Greenville, being shown as Lot 5 on a revised plat of Airport Village Farms made by Woodward Engineer Company in February, 1957, and according to plat of Airport Village Farms made by J.
