

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Northeast side of Hawthorne Lane, in the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 93 on plat of Langley Heights, made by Dalton & Neves, Engineers, June 1947, recorded in the RMC Office for Greenville County, S.C. in Plat Book N, Pages 132 and 133, and having, according to said plat and a survey made by R.E. Dalton, Engineer, April 1947, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Hawthorne Lane at joint front corner of Lots 93 and 94 and running thence along the line of Lot 94, N. 41-50 E., 375.6 feet to an iron pin in center of Brushy Creek; thence down Brushy Creek to a point in said Creek (the traverse line being S. 44-50 E., 66.5 feet) at rear corner of Lots 92 and 93; thence with the line of Lot 92; S. 44-23 W., 373 feet to an iron pin on the Northeast side of Hawthorne Lane; thence with the Northeast side of Hawthorne Lane, N. 47-17 W., 50 feet to the beginning corner.
