ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known anddesignated as lot 475A Burmaster Drive, Section D of Englewood Estates as shown by a plat thereof, dated February 1955, recorded in the R.M.C.Office for Greenville County, South Carolina in Plat Book "BB", at page 177, and having the following metes and bounds:
