ALL that tract of land situate, lying and being on the Northeast side of the right of way of U. S. Highway No. 276; lyinge North with the Town of Fountain Inn, S. C., in Fairview Township, Greenville County, S. C., and having according to a survey made by Piedmont Engineering Service, August, 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast edge of the right of way of U. S. Highway No. 276 at corner of property of R. H.
