A right of way for purposes of ingress and egress only to property of the grantees over Cliff Ridge Road, also known as Cliff Road, and Round Mountain Road, both of said roads being shown on a plat entitled "Plat of access road to WSPA-TV Tower Site, Caesar's Head", made by Piedmont Engineering Service March 7, 1960, and recorded in the office of the R.M.C. for Greenville County in Plat Book QQ , Page 157

A portion of said roads is also shown on a plat entitled "Proposed Transmitter Site for WMRC, Inc. (Site No. 1)", made by Piedmont Engineering Service May 21, 1956, revised May 19, 1958, and recorded in the office of the R.M.C. for Greenville County, South Carolina in Plat Book MM, Page 3.

As to that part of said roads shown on the aforementioned plat extending from the intersection of the Cliff Road and Round Mountain Road in an easterly or northeasterly direction, the grantor herein reserves the right to relocate and substitute portions of said above-mentioned road or, roads provided that no portion of the said road or roads is varied a distance of more than one-hundred (100) feet from the centerline of the now existing road or roads.

As to that part of said roads shown on the aforementioned plat extending from the intersection of the Cliff Road and Round Mountain Road southwesterly to the Geer Highway, the grantor herein also reserves the right to relocate and substitute portions of said above-mentioned road or roads.

In the event of the relocation or substitution of any of the above-mentioned roads from the Geer Highway (United States Highway No. 276) to the property of the grantees, such relocations or substitutions shall be comparable in all respects to the previously existing road, or roads, particularly with reference to terrain, grades and courses, the then condition of the road to be replaced as to construction, width and finish, and the distance of the same from the property of the grantee to the now existing Geer Highway (United States Highway No. 276).

This right-of-way is conveyed subject to the existing rights of others in and to the aforementioned road, or roads.
