years upon the same terms and conditions as therein set forth, except as follows:

Lessee shall pay the following rent: An amount equivalent to One Cent (1¢) for each gallon of gasoline and other motor fuels sold during the month or fraction thereof at said premises by Lessee, its Sublessees or Assigns, said rental to be payable on or before the 15th day of the month following the month in which the rental is earned; provided that said rental shall in no event be less than ONE HUNDRED DOLLARS (\$100.00) for each successive monthly period hereof. Lessee shall keep, or cause to be kept, such records as will accurately show the number of gallons of gasoline and other motor fuels sold at the demised premises and will permit Lessor to inspect such records at any time and from time to time during business hours when Lessor desires so to do.

Lessee hereby agrees to paint the service station building twice during the extension period of this lease at times when lessee so deems it necessary so to do.

Lessee shall have the privilege and option of renewing the lease aforesaid and the purchase option therein ) additional periods of one year each, the first of contained for said periods to begin on the expiration of the first period herein granted and each successive period to begin on the expiration of the period then in effect upon the same terms and conditions set forth in the lease and purchase option aforesaid (except as noted above) and all of said privileges and options of renewal shall be considered as having been exercised unless Lessee gives Lessor notice in writing at least thirty (30) days prior to the expiration of the period then in effect of its intention not to exercise such renewal privilege.
