PROTECTIVE COVENANTS APPLICABLE TO SECTIONS I, IA, AND II OF NORTHWOOD HILLS, A SUBDIVISION NEAR THE CITY OF GREENVILLE, AS SHOWN BY A REVISED PLAT MADE IN AUGUST 1960 AND RECORDED IN PLAT BOOK QQ AT PAGE 156, IN THE RMC OFFICE FOR GREENVILLE COUNTY.

WHEREAS, by an instrument dated January 19, 1960 recorded in Deed Book 643 at Page 135, in the RMC office for Greenville County, Colonial Mortgage and Realty Co., a corporation, imposed the covenants therein contained upon Section I of Northwood Hills, as shown by a plat recorded in Plat Book RR at Page 15; and
