All that certain piece, parcel or lot of land in Greenville Township, Greenville County, City of Greenville, State of South Carolina, being shown as all of Lots Nos. 1 as shown on plat recorded in the RMC Office for Greenville County In Plat Book "S", Page 23, and having the following metes and bounds according to said plat and also according to amore recent plat of property of William L. Martin, Jr. and Martha S. G. Martin prepared by R. B. Bruce on 19 October, 1960:

BEGINNING at an iron pin on the Southerly side of Perrin Street at the joint front corner of Lots Nos. 1 and 2, and running thence S. 37-15 E., 182.4 feet to an iron pin; thence S.54-45W., 86.8 feet to an iron pin on the Easterly side of Keith Drive; thence with the said Drive, N. 35-45 W., 180 feet to an iron pin at the Southeasterly intersection of Keith Drive and Perrin Street; thence with Perrin Street, N. 53 E., 80 feet to the point of BEGINNING.

This is the same property conveyed to the grantor by deed of Leland H. James recorded in Deed Book 356, Page 500, less however, that portion of Lot No. 2 conveyed by Mark R. Osborne, Sr. to Ed B. Smith at Deed Book 477, Page 146, and Ed B. Smith joins in this deed to correct the error in said last mentioned deed wherein the call on the back line of that portion of Lot No. 2 is "82 feet to the joint rear corner of Lots Nos. 1 and 2", whereas the same should have read from the five (5) foot easement "S. 54-45 W., 77 feet to joint rear corner of Lots Nos. 1 and 2, and said Ed B. Smith does hereby convey to the grantees herein any right or title he may have received under said deed (477-146) in Lot No. 1, the property herein conveyed.
