to the grantor(x) in hand paid at and before the sealing of these presents by the grantee(x) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Emmette L. Meares, his heirs and assigns,

All that piece, parcel or lot of land, including the buildings and improvements thereupon situate, lying and being on the Northerly side of Echols Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 12 according to plat of Property of Elizabeth E. Voyles, prepared by Pickell and Pickell, Engineers, July 1950, as recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book "Y" at page 73, and having according to more recent survey the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northerly side of Echols Drive at joint front corner of Lots 11 and 12, said pin being 1186.8 feet in an Easterly direction from iron pin in the Northeast corner of the intersection of Augusta Road and Echols Drive, and running thence along the joint line of those lots N. 21-42 W. 115 feet to an iron pin; thence N. 63-18 E. 100 feet to an iron pin at joint rear corner of Lots 12 and 13; thence along the joint line of those lots S. 21-42 E. 115 feet to an iron pin at joint front corner of Lots 12 and 13 on Echols Drive; thence along said Echols Drive S. 68-18 W. 100 feet to an iron pin, the point of beginning.
