All that piece, parcel or lot of land with the improvements thereon, situate, lying and being in the Dunean Mills Village, Greenville County, South Carolina, and being more particularly described as Lot No. 29, Section 4, and the adjacent pumping station lot as shown on a plat entitled "Subdivision for Dunean Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., on June 7, 1948, revised June 15, 1948, and August 7, 1948, and recorded in the R. M. C. Office for Greenville County in Plat Book S, at pages 173-177, inclusive, and having, in the aggregate, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Smythe Avenue at the joint front corner of Lots Nos. 28 and 29, and running thence with the line of Lot No. 28 S. 57-55 E. 188.2 feet to an iron pin on the Western side of a 15 foot alley; thence with the Western side of said 15 foot alley S. 29-10 W. 9 feet to an iron pin; thence continuing with the Western side of said 15 foot alley S. 39-10 W. 45 feet to an iron pin; thence still continuing with the Western side of said alley S. 53-40 W. 27 feet to an iron pin at the joint rear corner of the pumping station lot and Lot No. 30; thence with the line of Lot No. 30 N. 55-43 W. 173.9 feet to an iron pin on the Eastern side of Smythe Avenue; thence with the Eastern side of Smythe Avenue N. 32-35 E. 72 feet to the point of beginning.
