








## Know All Men by these Presents:

PAGE, HER HEIRS AND ASSIGNS FOREVER:

All that certain piece parcel or lot of land in Greenville County, State of South Carolina, in the City of Greenville, on the Southern side of Hamilton Avenue, and being lot # 21 on plat of property of H. T. Mills, recorded in the RMC office for Greenville County, in Plat Book C at Page 223, and being more fully described as follows:



BECINNING at a point on the southern side of Hamilton Avenue, 100 feet from the intersection of Hamilton Avenue and Calhoun Street, at corner of lot ₩ 20, thence S. 16-45 W. 132.6 feet to stake; thence S. 77-45 d. 10 feet 1-1/2 inches to stake, corner of lot #22; thence along the line of lot \* 22, N. 16-15 E. 135 feet to stake on Hamilton Avenue; thence along Hamilton Avenue as the line, N. 73-65 W. 50 Seek to the beginning corner.
