FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is MUTUAL PETROLEUM COMPANY INC.

THIRD: That the principal place of business is 904 Pickney Street, Ext., P. O. Box 955, GREENVILLE, SOUTH CAROLINA
