All that certain lot of land lying at the northwestern corner of intersection of Long Hill Street and Pleasant Ridge Avenue, shown as Lot No. 13 on a plat of Pleasant Valley, recorded in Plat Book P at page 92 in the RMC office for Greenville County, and being further described according to said plat as follows:
