in consideration of \$2895.44 and the assumption of the below described mortgage the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release J. C. Burdette, his heirs and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon on the Northern side of Woodfin Avenue (formerly known as McKay Street) in the City of Greenville, County of Greenville, State of S. C., and being known and designated as all of Lot No. 2 and a portion of Lot No. 1 as shown on plat prepared by R. E. Dalton, dated November 1924, entitled "Property of R. J. Williams " and recorded in the R. M. C. Office for Greenville County in Plat Book F at page 263, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the Northern side of Woodfin Avenue (formerly known as McKay Street) at the joint front corner of Lots Nos. 2 and 3, which point is 294.3 feet West of the intersection of Augusta Street and Woodfin Avenue, and running thence with the line of Lot No. 3, N. 3-46 W. 173.9 feet to an iron pin; thence S. 88-47 E. 70.2 feet to an iron pin in the rear line of Lot No. 1, which iron pin is S. 88-47 E. 20 feet from the joint corner of Lots 1 and 2; thence a new line through Lot No. 1, S. 3-46 E. 167 feet, more or less, to an iron pin on the Northern side of Woodfin Avenue, which iron pin is 224.3 feet from the intersection of Augusta Street and Woodfin Avenue; thence with the Northern side of Woodfin Avenue S. 86-14 W. 70 feet to the point of beginning.
