in consideration of Three Hundred (\$300.00) ----the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Pinson Dunn, his heirs and assigns forever,

All that piece, parcel and lot of land located in Gantt Township, Greenville County, State of South Carolina, being in the northwest corner of a tract of land now owned by the grantor and described more particularly as follows:

BEGINNING at an iron pin on the rear of a lot now owned by Maude H. Miller in the extension of the property line between her and Clarence Burgess and running thence with the line of the Miller lot in a northerly direction 205 feet to an iron pin on the rear corner of the Miller lot, said pin being located in the line of land formerly owned by James Scott; thence running in an easterly direction along the line of land formerly owned by James Scott 102 feet to an iron pin; thence running a new line parallel to the line of the Miller lot in a southerly direction 204 feet to an iron pin; thence a new line through the lands of grantor 102 feet in a westerly direction to the point of beginning and containing 1/2 acre more or less. THE Grantee reserves a 12 foot right-of-way to and from dirt County Road leading off. of Staunton Bridge Road, a distance of 168' from Grantees Line to said County Road, St. Side this being made a part of this deed)

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or apper-taining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s') heirs or successors and administrators to warrant and forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and against every person whomsoever law-fully claiming or to claim the same or any part thereof.
