to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ann Carver, her heirs and assigns forever, all that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being in the City of Greenville, State of South Carolina, at the northwest corner of Earle and Elizabeth Streets, and being known and designated as the southern portion of Lot No. 8, of Section F, of the Stone Land Company Subdivision, as shown on a plat recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "A", at page 337, et seq, and a more recent survey thereof by R.K. Campbell of Ann Williams property dated July 30th, 1962, and having according to said last mentioned plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwest intersection of Earle and Elizabeth Streets and running thence with the west side of Elizabeth Street N. 18-30 E 124.15 feet to an iron pin; thence N. 64-45 W. 63.92 feet to an iron pin; thence S. 18-30 W. 131.5 feet to an iron pin on East Earle Street; thence with the northerly side of East Earle Street S 71-20 E. 63.81 feet to an iron pin, the point of beginning.

This is a portion of the same property conveyed to the grantor by E.H. Reeves by deed dated February 28th, 1962, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 704 , at Page 111 ; which was conveyed to E.H. Reeves by J. Rion McKissick by deed dated May 10, 1928, and recorded in the R.M.C. Office for Greenville County, S.C. in Deed Book 115, page 31; which was conveyed to J. Rion McKissick by W.D. Parrish, and T.C. Gower by deed dated October 23, 1920, and recorded in the R.M.C. Office in Deed Book 68 at page 282; which was conveyed to W.D. Parrish and T.C. Gower by H. B. Bates by Deed dated February 6, 1920, and recorded in Deed Book 63 at page 190.
