H. Trammell and C. E. Robinson, Jr., recorded in the RMC Office for Greenville County, S. C., in Plat Book V, page 33 and having according to a survey made by Dalton & Neves in February 1959 for Furman Middleton, Jr. the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Beck Avenue, said iron pin being 302.3 feet west of an iron pin on the Northwest corner of the intersection of Beck Avenue and Old Augusta Road; and running thence along Beck Avenue S. 89-47 W. 80 feet to an iron pin; thence N. 0-13 W. 240 feet to an iron pin; thence N. 89-47 E. 80 feet to an iron pin; thence S. 0-13 E. 240 feet to an iron pin, the point of beginning.
