

All that certain lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the northeast side of Cardinal Drive, being known and designated as Lot No. 32 of Cardinal Park, property of Oscar L. Ayers, as shown on plat made by R. K. Campbell, April 24, 1949, and recorded in the R. M. C. Office for Greenville County in Plat Book W, page 27, and having the following metes and bounds:
