

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 89, as shown on a plat of Camelot Court by John A. Simmons, Surveyor, dated March 1962 and recorded in the R. M. C. Office for Anderson County in Plat Book 47, at Page 215, and having according to said . plat the following metes and bounds, to-wit:
