All that certain piece, parcel and lot of land situated lying and being in the County and State afare said about one and a quarter miles from Greenville Court House and having the following lines, meters and bounds to wit. Having a front of ninety eight (98) feet on Wilkins Street on the south and running back on paralled lines one hundred and twenty two feet to the back line, said back line having the same length as the front and lying on the east side and adjoining another lot also belonging to me and containing 11956 feet more or less.

- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
