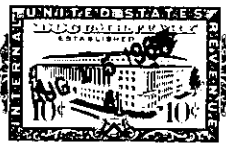
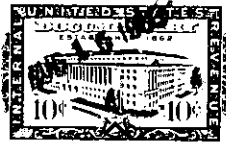

in consideration of Seven Thousand and no/100-----(\$7,000.00)-----Dollars,

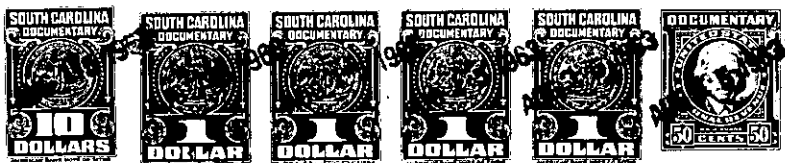

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Western side of Sumner Street, in the City of Greenville, being a portion of Lots Nos. 2 and 4 of Block A, as shown on Plat recorded in Plat Book A, at pages 122 and 123, and, also, being shown as Lot No. 9, Section 3, Page 77, of the City Block Book, and being more particularly described by metes and bounds, as follows:

BEGINNING at an iron pin on the Western side of Sumner Street 150 feet North from the corner of Arlington and Sumner Street, and running thence with the line of Sumner Street N. 17 E. 51 feet, more or less, to an iron pin corner of lot now or formerly owned by T. A. Baugh; thence N. 72-58 W. 135 feet to a corner of the lot now or formerly owned by R. L. 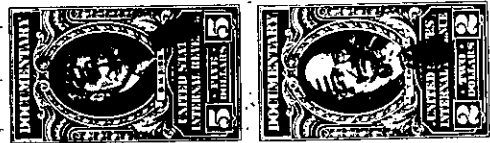
