KNOW ALL MEN BY THESE PRESENTS, that I, Harrison Gambrell, of Greenville County,

Twenty-One Hundred and No/100 (\$2,100.00) - - - - in consideration of and assumption of mortgages set out below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release J. P. Medlock, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being shown as Lot 11 on the Plat of College Heights made by Dalton & Neves, Engineers, recorded in the R.M.C. Office for Greenville County in Plat Book "P", page 75, and having, according to said plat, the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the south side of East North Street Extension at the corner of Lot No. 12, and running thence along the line of that lot, S. 33-10 E. 200 feet to an iron pin; thence S. 56-50 W. 116.3 feet to an iron pin; thence N. 21-30 W. 204.2 feet to an iron pin on the south side of East North Street Extension; thence along the south side of East North Street Extension, N. 56-50 E. 75 feet to the beginning corner; being the same property conveyed to me by Perry S. Luthi, Builder and Contractor, Inc. by deed dated August 15, 1956 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 559 at Page 382.

As a part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on that certain note and mortgage, in the original sum of \$ 9,000.00 executed by the grantor to the First Federal Savings and Loan Association of Greenville and recorded in the R.M.C. Office for Greenville County in Mortgage Book 688 at Page 345, the balance due thereon being the sum of \$ 6,897.64 as of this date.

As a further part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on that certain note and mortgage in the original sum of \$ 2,500.00 executed by the grantor to Perry Luthi, as Trustee, and recorded in the R.M.C. Office for Greenville County in Mortgage Book 688, at Page 337, the balance due thereon being the sum of \$2,197.88

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
