BEGINNING at an iron pin on the North side of East North Street, which iron pin is 105.87 feet West from the Northwest corner of the intersection of Thompson Street and East North Street, and is at joint front corner of property now cwned by Featherknit Fabrics, Inc. (See Deed Book 546, Page 106) and runs thence along line of property of Featherknit Fabrics, rage 100) and runs thence along line of property of Featherkhit Fabrics, Inc.
