ALL that piece, parcel, or lot of land in Paris Mountain Township, Greenville County, South Carolina, on the north-eastern side of Hunts Bridge Road, being known and designated as Tract No. 4 of the property of the T. F. Simpson Estate, and having, according to a plat of the T. F. Simpson Estate, dated October 11, 1963, made by J. C. Hill, L. S., and recorded of even date, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Hunts Bridge Road at the joint front corner of Tract No. 4 and property now or formerly of Bertha S. Cook, and running thence N 42 E 1285 feet to an iron pin; thence S 36 W 330 feet to a point at a poplar; thence S 40 1/2 W 1386 feet to a point on the northeast side of Hunts Bridge Road; thence with the northeast side of Hunts Bridge Road, S 43 E 310.2 feet, more or less, to the point of beginning, and containing 10.3 acres, more or less.
