heirs and assigns, forever; subject, however, to the restrictions and limitations above referred to.

nants with the said VERNON N. & DORIS S. MORRIS  
that the lot shall receive general care as specified in Rule No. 5 on the reverse side hereof to which reference is  
made.

And GRACELAND CEMETERY DEVELOPMENT CO., INC., does hereby bind itself and its successors to  
warrant and forever defend the said premises to the said VERNON N. & DORIS S. MORRIS, THEIR  
heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to  
claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
