to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HENRY P. WILLIMON, his heirs and assigns forever,

ALL that tract of land in Oaklawn Township, Greenville County, South Carolina, containing 266.38 acres, more or less, having the following metes and bounds:

BEGINNING at an iron pin at the corner of land now or formerly belonging to Mary B. Eskew and Walter Chandler, and running thence along the Eskew line erace N. 1 - 45 W., 24.95 chains to a corner in the road; thence N. 48 - 30 W., 12.57 chains along the road, to a stone; thence N. 5 - 45 W., 31.00 chains to an iron pin; thence N. 59 E., 30.95 chains to an iron pin on line of property now or formerly belonging to Hopkins; thence along Hopkins line and the line of property now or formerly belonging to W. J. Hedden S. 52 - 30 E., 42.50 chains, crossing creek, to a stone on line of property now or formerly belonging to Harrison Coker; thence with Coker's line, S. 37 - 45 W., 28.60 chains to a white oak; thence S. 48 - 40 E., 3.86 chains to an iron pin; thence S. 35 - 40 W., 24.62 chains to an iron pin; thence S. 63 W., 19.70 chains to the beginning corner.
