Grantee(s), and to the heirs and assigns of said Grantee(s), the following described real estate situate in the County of GREENVILLE, State of South Carolina, to wit:

All those piece, parcels or lots of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South C rolina, being known and designated as part of Lots Nos. 31 and 32 on plat of Property of W.A. Sanders, Paris Heights, as per plat thereof recorded in the RMC Office for Greenville County, S.
