

ALL that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the northeastern corner of the intersection of Mayflower Avenue and Pecan Drive and being known as Lot No. 37 of Pecan Terrace as shown on plat thereof prepared by Piedmont Engineering Service dated March 27, 1953, and recorded in the RMC Office for Greenville County in Plat Book "GG" at page 9 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Pecan Drive, joint front corner of Lots 36 and 37 and running thence along said Drive S. 52-22 E. 90 feet to an iron pin; thence with the curve of the intersection of Pecan Drive and Mayflower Avenue N. 82 E. 35 feet to an iron pin; thence along Mayflower Avenue N. 36-23 E. 60 feet to an iron pin joint corner of Lots 19 and 37; thence N. 39-26 W. 110.6 feet to an iron pin; thence S. 40-27 W. 109.8 feet to the point of beginning.

The above described property is the same conveyed to the grantor by deed recorded in Deed Book 745 at page 238.

As a part of the consideration for this conveyance the grantee assumes and agrees to pay the balance due on the mortgage given by Wilburn Turnmire to Aiken Loan and Security Company, the balance on which is not to exceed \$8600.00. This mortgage is recorded in Mortgage Book 724, page 179.
