

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, near Paris Station, according to a plat called "Map of Piedmont Estates, Paris Station" made December, 1944 by Dalton & Neves, and being recorded in the R.M.C. Office for Greenville County in Plat Book M, Page 123, said lot being shown on plat as Lot No. 35 and being more particularly described as follows:

BEGINNING at an iron pin on the Southeast side of Churchill Avenue, joint front corner of Lots Nos. 36 and 35 and running thence along Churchill Avenue S. 23-15 W. 60 feet to an iron pin; thence S. 66-0 E. 172.7 feet to an iron pin; thence N. 24-0 E. 60 feet to an iron pin; thence N. 66-0 W. 173.5 feet to the beginning corner.

- No dwelling shall be erected on any of these lots costing less than \$2,000.00.
