ALL that piece, parcel, or lot of land, with the buildings and improvements thereon, in the City of Greenville, County of Greenville, State of South Carolina, on the northwest corner of Park Avenue and Rowley Street, and having the following metes and bounds, to-wit:

BEGINNING at a stone post on the northwest corner of Park Avenue and Rowley Street, and running thence along the west side of Rowley Street, N 20-19 E 140 feet to a stake on a 10 foot driveway; thence along said driveway, N 77 W 100 feet to an iron pin on the property now or heretofore belonging to E. N. Mittle; thence S 20-19 W 140 feet with the line of said Mittle property to an iron pin on the north side of Park Avenue; thence with Park Avenue, S 77 E 100 feet to the point of beginning.
