- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property scribed below, or any interest therein; and

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the southeast corner of Club Drive and Byrd Boulevard (formerly Ridge Drive), in the City of Greenville, being shown as Lots Nos. 208 and 209 on plat of Marshall Forest, recorded in Plat Book "H" at Pages 133 and 134, and descirbed as follows:

BEGINNING at a stake at the southeast corner of Byrd Boulevard (formerly Ridge Drive) and Club Drive, and running thence with the southern side of Club Drive, N. 73-00 E. 162.8 feet to a stake on an alley; thence with the western side of said alley in a southerly direction 41.1 feet to a stake at corner of Lot 207; thence with line of said lot S. 66-12 W. 172.4 feet to a stake on Byrd Boulevard (formerly Ridge Drive); thence with the eastern side of Byrd Boulevard (formerly Ridge Drive), N. 23-48 W. 58.8 feet to the beginning corner.

That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is increby authorized to rell thereon
