All that certain piece, parcel or tract of land situate, lying and being in Greenville County, State aforesaid, near Greenville, South Carolina, containing 29.68 acres, more or less, according to survey of property of Travis J. Cash, Jr. and F. Harold Gillespie made by Carolina Engineering and Surveying Co., October 28, 1964, and according to said plat being more particularly described as follows:
