

ALL that certain piece, parcel or lot of land, with all improvements thereon, situate; lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the South side of Ike's Road, and being known and designated as Lot No. Nine (9) of Rosewood Park as shown on plat prepared by Terry T. Dill, Reg. C. E. dated Oct. 3, 1959 and which plat has been recorded in the R. M. C. Office for said county in Plat Book TT, page 30, and having the following courses and distances, to-wit:

BECINNING at an iron pin on the South side of said road at the joint front corner of Lots Nos. 9 and 10 as shown on said plat, and running thence with the joint property line of said two lots S. 26-06 E. 171.2 feet to an iron pin at the joint rear corner of Lots Nos. 9, 10, 20 and 21 as shown on said plat, thence with the joint property line of said lots nos. 9 and 21 S. 80-08 W. 108.8 feet to an iron pin at the joint rear corner of Lots Nos. 8, 9, 21 and 22 as shown on said plat, thence with the joint property line of said Lots Nos. 8 and 9 N. 20-40 W. 155.4 feet to an iron pin on the South side of said Road, thence with the South side of said Road, thence with the South side of said Road N. 66-02 E. 95 feet to the beginning point.
