KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

in consideration of Five Hundred Forty & NO/100. (\$540.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Nellie C. Buckner, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Chick Springs Township, being known and designated as Lots 65 and 66 of a subdivision known as Holly Vista, as shown by a plat thereof, dated February 1956, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Millervale Road, joint front corners of Lots Nos. 64 and 65 and running thence along the lines of said lots, N. 44-48 E. 149.4 feet to iron pin; thence running with rear lines of Lots 65 and 66, S. 25-30 E. 106.2 feet to iron pin rear corner of Lot 67; thence running with line of said lot, S. 44-48 W. 96.8 feet to iron pin on Millervale Road; thence running with Millervale Road, N. 61-05 W. 104 feet to iron pin point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS deed is made subject to all easements and rights of way of record.
