the Train Dispatcher and Chief Dispatcher to exercise supervisory control over dispatch services, i.e.: (1) to permit the Dispatcher access to any VHF station in a particular division, for origination of a message to train or work crews in any area of the railway operations; and (2) to permit the Dispatcher to switch to standby equipment.

. . . .

The Communication System is a necessary part of the Lessees' computerized information control designed to provide data needed for improved distribution of cars and car handling, thereby materially lowering capital requirements for equipment. These data will provide continuous control of loaded car movements and will afford opportunity for corrective measures where standards are not maintained, thereby assuring improved customer service. The Communication System is also designed to support the data processing for cost control, accounting, operating statistics, supervisory control of roadway and mechanical maintenance, as well as marketing, commodity and traffic research, and sales analysis and evaluation, on a current basis.

The premises and facilities leased under the Series A Lease of which this Schedule A is a part include the following described parcels of land owned by Citico Realty Company, and leasehold and other interests held by it, together with any and all towers, buildings, structures, equipment and facilities hereinbefore described located on or associated with such parcels or other interests:
