Chick Springs Township, lying on the northwestern side of Lincoln School Circle and being known and designated as Lot No. 10, Block 1, of the property of Mrs. C. B. Loftis, according to a plat thereof prepared by Terry T. Dill, Surveyor, August 8, 1955, and having, according to said plat, the following metes and bounds, to-wit:
